PLEASE NOTE ALL CHANGES IN INFORMATION on the entry form, otherwise they will not be made.

Telegraph, Telephone and Unsigned Entries cannot be accepted. Entries not on Official AKC Entry Forms, downloaded and/or photocopies of Entry Form without Agreement and Rules on the reverse side of the Official AKC Entry Form are **NOT ACCEPTABLE**.

Acknowledgment of entries will be made as soon as practicable should such acknowledgment not be received within a reasonable time, please contact the show Secretary.

Make all checks payable to Poodle Club Of Central Indiana. Canadian exhibitors must make fees payable in US funds. Please mail check or money orders with entries. The Show Secretary assumes no responsibility for cash sent through the mail.

An AKC Recording Fee of \$.50 first entry only and an AKC Event Service Fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking test. The fees are to be collected by the trial-giving Club and paid to the American Kennel Club. The recording fee and event service fee are included in the entry fee.

No Entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judged or barred from competition by action of the show committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management, it is impossible to open or to complete the event, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the event before completion, no refund of entry fee will be made. To find out about any AKC event cancellations call the AKC Event Cancellation Hotline (877) 252-3229.

Post Dated and Returned Checks do not constitute a valid entry fee. The show-giving Club will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

No Refund for duplicate entries. Every effort to find all duplicate entries will be made, however if an entry has been processed no refund will be made.

Errors on entry blanks. Owners are responsible for errors in making out entry forms, whoever may make such errors and no entry fee will be refunded in event of such errors or cancellations of entries after the published closing date.

As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Judges will not wait for any dogs holding up a class. Owners and agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All dogs present must be held on leash or confined to their crates except when being judged or when in the exercise ring.

All Exhibitors are responsible for cleaning up after themselves and their dogs.

Class cash prizes will be paid in the ring to the person showing the dog. Claims for prize money must be must in the ring before judging of that breed is over and the Superintendent office is advised at once. The show-giving club disclaims any liability for cash prizes after the judging of the breed is over.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.

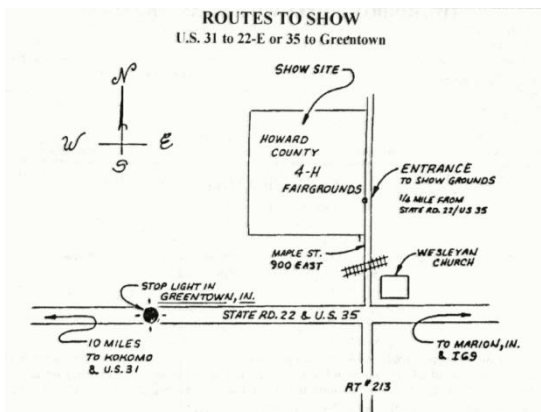
